

- 6. Electronic bids must be submitted to through PPMO website <a href="www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a>on or before 12 on 2077/10//27 (2021/02/09). Bids received after this deadline will be rejected.
- 7. The bidswill be opened in the presence of Bidders' representatives who choose to attend at 1 pm 2077/10/27 (2021/02/09) at the office of Kamal Rural Municipaliit, Topgachhi jhapa. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting as per above table which shall be valid for 30 days beyond the validity period of the bid
