- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1 PM 2077/09/19 (2020/01/03) at the office of Kamal Rural Municipaliit, Topgachhi jhapa. Bids must be valid for a period of 90days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting as per above table which shall be valid for 30 days beyond the validity period of the bid
